2. The competition is open to all high school and middle school cheerleading and dance squads in New Hanover, Brunswick and Pender Counties.
3. There will be (4) divisions – Middle School Cheerleading, Junior Varsity Cheerleading, Varsity Cheerleading and Dance Squads.
4. Squads will assemble at the entrance to the CFF&E fairgrounds and enter all at one time. **ALL** squad members should be ready and in uniform 30 minutes prior to the contest.
5. **ONLY** the cheerleading/dancer and advisor is admitted free of charge. **ALL** other students and family **MUST** purchase a ticket. The performers and advisors must enter at the same time. One student School Advisor **MUST** accompany the team.
6. **A list of the names of performers MUST be presented and will be checked before entry into the fair. Please use the enclosed performer list and mail it back with this registration form.**
7. Each squad will perform a cheer, chant and dance combo that should NOT exceed 2 ½ minutes – these performances will be held in an open area.
8. Advisors will meet or make contact with this competition’s coordinator at least fifteen (15) minutes before the contest.
9. Trophies and ribbons will be awarded to the first, second and third place teams in each division.
10. Each squad will be judged in group performance, group cheer, group stunt, group dance, appearance, voice inflection, facial expression, motion technique, spirit, enthusiasm and gymnastics.
